Who is eligible?

Low income individuals with five or fewer City of Wichita or Sedgwick County District Court (18th Judicial District) convictions. Your crime must be eligible for expungement. You must have fulfilled your sentence (including the payment of all costs, fees, and restitution), and the required waiting period must have passed.

What to do

To participate in Clean Slate Day, you must come in person, fill out an information form, and go through a background check to see if you are eligible for a no-cost Clean Slate expungement.

(You may print and fill out your information sheet in advance by going to www.wichitabar.org/cleanslateday.php. There you may view and print out the forms.)

If the background check shows you are eligible and you meet all other criteria, Clean Slate's volunteers, including volunteer lawyers, will assist you in preparing and filing the expungement paperwork.

While it is still up to the judge to decide whether to grant the expungement, in certain cases, it may be possible to receive an expungement the same day.



What to bring

Please bring photo ID (driver's license, ID card, student ID, passport) and be prepared to provide information about your background, including your current address and phone number.

***Important Information ***

Convictions OUTSIDE the City of Wichita Municipal Court or Sedgwick County District Court ARE NOT within the scope of Clean Slate Day Project.

Not all criminal convictions are eligible for expungement, and no-cost expungements are not guaranteed to anyone participating in this project.

- Murder in the first or second degree

- Voluntary or involuntary manslaughter
- Sexual battery when victim is less than 18 years old
- Involuntary manslaughter while DUI
- Aggravated sexual battery
- Commercial DUI, including any diversions for such violation
